GENERAL RULES AND REGULATIONS 2024

- The show is open to the following school districts; Allen ISD, Anna ISD, Blue Ridge ISD, Celina ISD, Community ISD, Farmersville ISD, Frisco ISD, Lovejoy ISD, McKinney ISD, Melissa ISD, Plano ISD, Princeton ISD, Prosper ISD, Royse City ISD, and Wylie ISD, or a student who resides in Collin County and attends a private school outside of Collin County that is at least 8 years old and in the 3rd grade and a member of the FFA or Jr. FFA, or 4-H Club in Collin County and in good standing with Texas FFA and Texas 4-H. Exhibitors D.O.B. will be put on the entries by the AST or CEA.
- 2. Ownership and custody of animal(s) will be by the students and immediate family from validation to sale day under the direct supervision of AST or CEA at the Project Center, home or leased housing for the animal.
- 3. Any exhibitor caught in violation of ownership Rule #2 will forever be barred from the Collin County Jr. Livestock Show.
- 4. All exhibitors will be under the control, jurisdiction, and governance of the General Superintendent.
- 5. Any individual not complying with the rules and regulations set forth in this catalog will forfeit all awards presented at the show.
- 6. The decision of the judges will be final. Any exhibitor who shows disrespect to a judge will be promptly disqualified.
- 7. The Collin County Livestock Show Association nor any show official will not be liable for any damages, fire, theft, or accident during the show.
- 8. The rules and regulations of the Livestock Sanitary Commission of Texas will be in effect. Collin County Livestock Show reserves the right to consult the show veterinarians to determine if an animal is healthy or unhealthy. If deemed to be unhealthy, the determined animal(s) shall be removed from the show grounds.
- 9. Exhibitors will be required to furnish feed and care for their animals during the show.
- 10. Night Curfew: Lights in the barn will be turned off at 12am each night, and will remain off until 5am. Curfew goes into effect at that time; person(s) will not be permitted to stay on grounds. No minors shall be left unsupervised in the evenings. Stock Show Officials and Myers Park Staff do not count toward that supervision.
- 11. Animals will be admitted to the grounds according to the unloading schedule. All animals must be in place by the time designated in the unloading schedule. All livestock/projects must be removed from the Meyers

Event Center grounds the day they are released. An exception would be made for exhibitors showing both goats and lambs. In this case, both should be removed after the conclusion of the lamb show. A fine of \$100 per animal/project will be assessed to any Chapter or Club that fails to properly remove animals/projects after their release. The exhibitor, if not a senior, will be banished for 1 year from showing any animal/project at the Collin County Livestock show.

- 12. All protests must be in writing and be accompanied by a deposit of \$150.00, which will be forfeited if the protest is not sustained. Such protest must state plainly the cause of complaint or appeal, and must be delivered to the livestock show management immediately after occasion for such protest. Protests will be accepted prior to judging or immediately at the conclusion of judging. The decision of the General Superintendent and Division Committee is final.
- 13. No alcoholic beverages will be permitted on Meyers Event Center property.
- 14. The No Pass / No Play Rules will be in effect to comply with UIL guidelines.
- 15. Showmanship is in the following species/categories; Rabbit, Sheep, Goats, Swine, Steer, Heifer and Shop.
- 16. General rules are effective for 2 years unless by unanimous vote to correct an egregious mistake.
- 17. The Collin County Junior Livestock show reserves to the elected show officers the final and absolute right to interpret these rules and regulations and to determine and settle all matters, questions, and differences in regard to the exhibit, exhibitor and/or the Junior Livestock Show.
- 18. DNA Testing may be conducted for all Champions.
- 19. The decision of the classifier is final.
- 20. All animals shown at CCJLA will be shown according to state validation rules.

Entries, Deadlines and Schedules

- 21. All breeding rabbits and breeding poultry must be owned 6 weeks prior to the show. Animal papers will be checked. Exhibitors must own breeding rabbits 6 weeks prior to the show. All breeding animals DOB's are required on entries when it is turned in or it will not be accepted.
- 22. All online entries are to be submitted by December 5, 2023 at 11:59 pm.
- 23. Rabbit entry paperwork details are due December 12, 2023 to rabbit superintendent. A PDF form will be available online to print, online entries through ShoWorks are still to be made in the online entry system.

24. Entry Fees:

- 25. Entries along with proper entry fees and hard copy entry forms must be in the hands of the Show Treasurer no later than December 12, 2023. All entries must be made by the CEA or AST for each club or chapter. Late entries will be accepted by paying double entry fees, late entries may not be accepted at the show due to stalling issues. Please check with the show superintendent prior to late entries being brought/unloaded on the grounds. THE AG TEACHER OR COUNTY AGENT IS RESPONSIBLE FOR SEEING THAT ENTRIES ARE FILLED OUT PROPERLY.
- 26. STEERS, MARKET SHEEP, MARKET GOATS, MARKET SWINE, MARKET BROILERS, FRYERS and Heifers must be validated on or before the designated date to show or sale. NO LATE VALIDATIONS PERMITTED. Validation of market animals in siblings' names, if the exhibitors are in the same immediate household, will be allowed. Validation will consist of tagging and tattoos for Goats, Lambs, and Cattle and tagging or tattooing for Rabbits and Hogs. A MARKET ANIMAL MUST BE ENTERED BY ONLY ONE EXHIBITOR. Students may enter an unlimited number of market animals, but may only show two (2) market steers, goats, swine, fryers, broilers and market lambs.
- 27. Showmanship must be entered at the time of ShoWorks entries. Showmanship will be \$10 per student per species. This excludes shop and Horticulture divisions. Money must be turned in at the time of entry deadline. Late entries will be accepted for double the entry fee.
 - Showmanship age break is Senior showmanship 14 and up, Junior showmanship 13 and under. Age will be determined at the original closing date of entries.
- 28. All display and tack must be in place no later than 6pm Sunday night.
- 29. Cattle MUST be in place by 6:30 pm Thursday.
- 30. Swine will be weighed-in Monday upon arrival. Lambs and Goats will be weighed directly following the fungus check. Steers and commercial Heifers will be weighed-in on Thursday. See schedule of events for times.

Ribbon Auction

- A Ribbon Auction will be Saturday for market animals, shop projects, and horticulture projects per division rules. An exhibitor can sell 2 projects that qualify for the auction. Exhibitors may not qualify multiple projects in the same division (show). With the exception of: (1) The overall Grand and Reserve Grand of a species, (2) Champion/Reserve Champion Horticulture, (3) Champion/Reserve Champion Shop Project.
- 32. All Grand, Reserve Grand, Breed Champions and Reserve Breed Champions MUST SELL, unless one exhibitor owns more than 1 Breed or Reserve Breed Champion in a species.

Grand and Reserve Champions MUST SELL. Exhibitors may pull division winners of horticulture / ag mech shows if an exhibitor also makes sale with animal project(s). Students must pull Ag Mechanics or Horticulture Projects by 5 pm on **Friday** of the show. In the event that this occurs, another student from the Ag Mechanics or Horticulture show **WILL** bump into the sale order.

- 33. Sale order for all species. 33% of all breeds/divisions in all species are eligible for sale. No alternates will be selected for sale order.
- 34. If an animal is taken or pulled out of the Sale Order more than 30 minutes after the Sale Order has been picked, the student owning said animal/s will be banned from next year's Collin County Junior Livestock Show.
- 35. Exhibitors making auction will not be allowed to have another person in the ring with them, with the exception of Champion and Reserve Champion exhibitors who will be allowed to have other exhibitors in the ring to hold awards.Exhibitors that are to be present cannot have décor on them of any sort; this includes and is not limited to bows, signs, paint, hats, ect...
- 36. All market animals are eligible for Auction if selected by the judge during the selection of Sale Order.
- 37. An Auction is defined as: Each Auction qualifier will receive the amount of the bid price less the cost of the sale picture.
- 38. Collin County Junior Livestock Show is a Ribbon Auction Sale for Steers, Market Goats, Market Sheep, Poultry, Fryers, Swine, Horticulture Projects, and Shop Projects.
- 39. Any exhibitor, group, or party that disrupts the show or sale will be removed by security and permanently barred from future participation in the Collin County Livestock Show.
- 40. An exhibitor who does not wish to participate in the Sale Order Selection process must notify the Division Superintendent and/or the ring staff. Failure to do so could result in the exhibitor being barred from the next year's show.
- 41. Students/Parents seen soliciting Buyers during the sale will forfeit any sale monies and be banned from the next year's show.
- 42. Sale may be taped- Chapters or Clubs whose members violate sale rules will be fined \$100.00 per violation. Due before the entry deadline for the following year or entries will not be accepted.
- 43. CCJLA will provide a sales sheet after the completion of each species for the ag teachers and 4-H leader before the sale order is printed. Any corrections should be made immediately. It is the Ag Teacher/4-H Leader's responsibility to alert the show secretary to any errors.
- 44. Add-on bids are welcome to be made to any Ribbon Auction lots any time after the sale of such lots. All add-ons must be done through the Sales Office and will not be announced by the auctioneer.
- 45. There will be a processing fee of \$5 for add-ons requiring more than one attempt to collect.
- 46. The Exhibitor will not receive any sale money until all funds are collected or after the second attempt to collect has been made. If a processing fee is required it will be deducted from their sale check. There will be no more than 2 attempts made to collect any add-ons.

Fitting/Stalling/Ring

47. Only exhibitors and authorized persons will be allowed in the show ring during the showing of animals. This is to include selection of Sale Order and classification areas. A parent or alternate can hold an animal in sale order if the exhibitor has multiple, if said animal makes it to the front line for selection then an exhibitor must be present to show that animal.

- 48. All animals must be shown by the exhibitor. Exceptions to this rule include:
 - The student has 2 animals in the same class
 - Health reasons that have been cleared through the Show Superintendent.
 - Other school sponsored activities.
- 49. If an exhibitor has multiple projects in the same class they may use a substitute exhibitor. The substitute exhibitor must be from the same chapter/club, if chapter/club has additional entries in that species.
- 50. Aisles and alleys in the barn are to be kept clean and open at all times. Clipping and fitting of cattle should be done outside the barn. Touch ups on sheep and goats may be done inside the stall barn.
- 51. Tie space and pens will be assigned by the General Superintendent and the Superintendent of each division.
- 52. Consequence of cutting a tarp is \$500 without the superintendent's permission.
- 53. The Show and Classification process will be a blow and show only show. Therefore, there will be no use of paint, powders, dyes, oils, creams, or lotions on an animal in every species. The only acceptable dressing will be sheen or water.
- 54. Animal Welfare/Quality Sift: It is the responsibility of all exhibitors to provide proper and humane care and treatment to animals. Show Management and Show veterinarian reserves the right to disqualify and remove any exhibitor deemed to be in violation of this basic principle of animal husbandry.
- 55. In accordance with Section 42.09 as defined in the TX Health and Safety code, any exhibitor found in violation of the following actions is subject to disqualification and a \$10,000 fine.

Section 42.09 "Cruelty to Livestock Animals" of the The TX Health and Safety code prohibits a person from intentionally, knowingly or recklessly cruelly treating an animal. The following actions define cruel punishment.

- 1. Torturing an animal or in a cruel manner kills or causes serious bodily injury to an animal;
- 2. Without the owner's effective consent, kills, administers poison to, or causes serious bodily injury to an animal;

3. Fails unreasonably to provide necessary food, water, care, or shelter for an animal in the person's custody;

- 4. Abandons unreasonably an animal in the person's custody;
- 5. Transports or confines an animal in the person's custody;
- 6. Without the owner's effective consent, causes bodily injury to an animal;
- 7. Causes one animal to fight with another animal, if either animals is not a dog;
- 8. Uses a live animal as a lure in dog race training or in dog coursing on a racetrack; or
- 9. Seriously overworked an animal.
- Removal of Animals: The Show can remove any animal they deem unsuitable or objectionable, without furnishing reasons for the action. Entry fees already paid will be forfeited. The decision of Show Management is final and the exhibitor has no recourse.

<u>Awards</u>

- 56. Awards for each division will be determined by the Awards Superintendent and the Awards Committee.
- 57. All forfeited awards/cash/prizes etc. will become the property of CCJLA.

Commercial Exhibit Rules

- 1. The commercial exhibitor shall in no way exhibit or offer for sale any food for human consumption or confectionery which could be in direct competition with the Junior Livestock Show concession stand.
- 2. The commercial exhibit area will be designated by the show superintendent and Youth Park manager. The exhibitor will be charged \$100.00 per day. The check needs to be made payable to: Collin County Junior Livestock Association.
- 3. The commercial exhibitor will be set up for business by 10:00 am January 08, 2024, and remain open until 6:00 pm. The exhibit will be open for business each day thereafter from 8:00 am to 6:00 pm except Saturday, when the hours will be from 8:00 am until Premium Sale begins.
- 4. Electricity will be available for commercial exhibitors on a limited basis. The exhibitor will have to provide any extension cord and/or lights necessary for his or her exhibit.

Swine Division

Superintendent: Stevie Horton Assistant: Bart Dobbs, Kaelan Drennan and Austin Webster

1. Cordless Clippers will be allowed with no snaring at any time.

- 2. The swine show will show both barrows and gilts together.
- 3. Market Swine weigh-in and classifying: Monday, arrival schedule will be sent to AST/4-H Agent.
- 4. Qualifying weight range for Swine: 0-300 pounds, with 5 pound tolerance on the top end.
- 5. Swine will be divided into classes after weights are turned in.
- 6. Swine will be classified into one of the six breed classes.
 - White OPB
 - Black OPB
 - Duroc
 - Hampshire
 - York
 - Cross
- 7. At the conclusion of the sift each School/Club will be presented with "**One**" print out of their entries. All Changes will be made on this form and turned in to the show office within 30 minutes. Teachers/Leaders shall verify the information and sign.

Highlights from the General Rules:

- Limited to two (2) entries per exhibitor.
- 33% of each breed are eligible for the premium sale, the breed champion and reserve breed champion will not count toward the 33%. Sale order will be determined by the judge and be held at the completion of each class.
- Classification and /or Show will be a blow and show only show. Therefore, there will be no use of paint, powders, dyes, oils, creams, or lotions on an animal in every species. The only acceptable dressing will be sheen or water.
- Consequences of cutting a tarp without the Superintendent's permission is a \$500.00 fine.

Steer Division

Superintendent: Sean Williams Assistant: Trenton Whan and Kris Schertz

- 1. Cattle Ties outs will be assigned and available for purchase through ShoWorks, this will be a first come first serve. \$10 per tie out, a chapter/club cannot get more tie outs than entries.
- 2. Steers will divide into classes with as equal weight as possible.
- 3. A minimum weight will be required, 900 pounds.
- 4. Breed of steers:
 - **American Breeds and their crosses** (Brahman, Brangus, Santa Gertrudis)- should have predominant Bos indicus characteristics
 - English Breeds (Angus, Hereford, Shorthorn, Polled Hereford, Red Angus)
 - Exotic and their Crosses (Limousine, Simmental, Maine-Anjou, Chianina, Charolais, etc.)
- 5. Steers will be classified by the steer classifying committee, selected by the superintendent prior to the time of weighing.
- 6. The final decision in determining the breed the steer will show in is up to the steer classifying committee and all decisions are final.
- 7. Any questions, other than classifying, will come under the form of an Official Protest to the General Superintendent as outlined in the General Rules.
- 8. Grand Champion Steer will be the first to sell. Reserve Champion Steer will be second, then Breed Champions and Reserve Breed Champions will be selected for sale and then all remaining steers will be placed in order to be selected by the judge for Sale Order. Sale orders will be held at the completion of each division.
- 9. All ear tags shall be removed except for State Validation Tags.
- 10. No butt fans, or porticools are allowed in the cattle barn. Only hanging fans are allowed, but must be hung using a hook and not a wire, cable or rope.

Highlights from the General Rules/Calendar:

- Only two (2) steers per exhibitor may be shown
- All display and tack must be in place no later than 6pm Sunday night.
- Cattle MUST be in place by 6:30pm Thursday
- Weighing of Steers-Thursday 7pm
- 33% of Steers will qualify for the Ribbon Auction excluding the Breed and Reserve Breed Champions.
- Classification and /or Show will be a blow and show only show. Therefore, there will be no use of paint, powders, dyes, oils, creams, or lotions on an animal in every species. The only acceptable dressing will be sheen or water.

Breeding Beef Division

Superintendent: Shalley Boles Assistant: Sean Williams, Roy McGil and Jake Parr

Beef masters, Grey Brahman, Red Brahman, Brangus, Santa Gertrudis, Simbrah, Other American Registered Breeds, Angus, Red Angus, Hereford, Polled Hereford, Shorthorn, Charolais, Limousin, Maine-Anjou, Simmental, Chianina, and Other Registered Breeds.

- 1. Cattle Ties outs will be assigned and available for purchase through ShoWorks, this will be a first come first serve. \$10 per tie out, a chapter/club cannot get more tie outs than entries.
- 2. All breeds will show by age.
- 3. All single entry Heifers will only show in the Champion drive, they will not show as a single entry.
- 4. Beef cattle class will consist of the following:
 - Heifers Calved April 1 and after 2023
 - Heifers Calved Jan 01 March 30, 2023
 - Heifers Calved Oct. 01 Dec. 31, 2022
 - Heifers Calved July 01 Sept. 30, 2022
- Heifers Calved April 01 June 30, 2022
- Heifers Calved Sept. 01, 2021 thru March 31, 2022
- 5. The beef cattle superintendent and their assistants have the authority to request the verification of age of any animal that they feel is entered in the wrong class, anytime up to the judging of the animal's class in the show ring.
- 6. Original Registration papers will be required and checked.
- 7. Any other questions concerning the age of the animals outside of the superintendent must come under the official protest order in the general rules.
- 8. The final decision determining the class and breed the animal shows in is in the hands of the superintendent of the Breeding Beef Cattle, and the decision of the superintendent will be final.
- 9. Division Champions and Reserve Champions awards for American Division, British Division and Exotic Division
- Division Champions will receive a premium of \$300 and Reserve Division Champions will receive a premium of \$150.
- 11. A Supreme and Reserve Supreme Overall Heifer will be selected from division Champions.
- 12. If a heifer gets loose a second time in the show ring they are removed from the competition, class specific.
- 13. The ring superintendent has the authority to dismiss unruly animals.
- 14. No butt fans, or porticools are allowed in the cattle barn. Only hanging fans are allowed, but must be hung using a hook and not a wire, cable or rope.

Highlights from the General Rules/Calendar:

- All display and tack must be in place no later than 6pm Sunday night.
- Heifer Papers will be checked 5-6:30 PM Thursday
- Cattle MUST be in place by 6:30pm Thursday
- Classification and /or Show will be a blow and show only show. Therefore, there will be no use of paint, powders, dyes, oils, creams, or lotions on an animal in every species. The only acceptable dressing will be sheen or water.

Goat Division

Superintendent: Heather McGrew Assistant: Trey Shares and Delaney Thomas

- 1. Breeding Goat Show- a minimum of 10 breeding goats must be entered by the date set for show entries to have a breeding show. All breeding goats will show together and be divided into classes by age. Age will be determined by the show veterinarian upon check in.
- 2. Breeding Goat Classes:
 - 1. Does with Milk Teeth
 - 2. Two Tooth Does
 - 3. Four Tooth & Older Does
 - 4. Champion Female
 - 5. Res. Champion Female

3 All goats, including Breeding Goats must be Texas Major Show validated.

- 4. All market animals will be weighed in and will be divided into 12 classes by the superintendent.
 - 4 classes of light weight
 - 4 classes of medium weight
 - 4 classes of heavy weight
- 5. Horns– exhibitors will be required to have horns tipped on all goats prior to weigh-in. Animals not following this rule will be disqualified.
- 6. Hair– market goats must be slick shorn too within 3/8 inch of hair or less at the time of the show. There will be no shearing allowed on the show grounds. Only hand shearers and cordless clippers may be used for touch ups.
- Weight– there will be a minimum weight of 40 pounds and a maximum weight of 115 pounds.
 OFFICIAL WEIGH IN will follow fungus check.
- 8. Lambs/goats are not allowed to enter the lamb/goat barn until they have been cleared by the show veterinarian.
- 9. Inspection for live ringworm/fungus by the show veterinarian will take place from 7-10 AM on the Wednesday of the show week inside the cattle wash racks. Chapters and clubs should arrive based upon the time schedule created by the sheep superintendent or their designee. Each animal (market and breeding) will be examined by the show veterinarian(s) to gain access in the barn. All blankets and muzzles must be removed from animals and must be shorn according to the show regulations prior to inspection. The sheep/goat superintendent, show veterinarian(s), exhibitor, and chapter advisor or club representative are the only individuals permitted inside the cattle wash racks at the time of inspection. Animals with live ringworm and/or fungus (as deemed by (both) the show veterinarian(s) of the county show) will not be permitted to enter the lamb/goat barn and will not be permitted to participate in the Youth Show." The decision of the Show Veterinarian's is final.
- 10. Restraints– exhibitors will be allowed to use halters or collars in the show ring.
- 11. Sale order will be determined by the judge at the completion of each division. The overall Champion and Reserve Champion will be the first two market goats in the sale. After Champion and Reserve Champion are selected, the remaining goats and reserve division champion goats will be selected in order by the judge for sale order, with the remaining goats being selected to make the 33% sale order.
- 12. Showmanship– exhibitors will not lift the front legs of goats off of the ground during judging.

- 13. Showmanship will follow the conclusion of the goat show.
- 14. At the conclusion of the fungus check/official weigh in each School/Club will be presented with "One" print out of their entries. All Changes will be made on this form and turned in to the show office within 30 minutes. Teachers/Leaders shall verify the information and sign.
- 15. All coverings are to be removed prior to fungus check.
- 16. All tags are to be removed with the exception being what pertains to validation and breeding. All lambs and goats have only validation tags at the time of check-in.

Highlights from the General Rules:

- Market Goats- Limited 2 entries per exhibitor
- Classification and /or Show will be a blow and show only show. Therefore, there will be no use of paint, powders, dyes, oils, creams, or lotions on an animal in every species. The only acceptable dressing will be sheen or water.
- 33% of Market Goats are eligible for the Ribbon Auction, excluding the Division Champions and Reserve Division Champions.

Sheep Division Tim Johnson Memorial market Sheep Show

Superintendent: Luke Parr Assistant: Shalley Boles, Teah Barrientes and Taylor Noble

- 1. All sheep, including Breeding Sheep must be Texas Major Show validated.
- 2. Breeding Sheep Suffolk, Hampshire, Dorset, Rambouillet, Southdown, and Commercial
- 3. Breeding Sheep Show- a minimum of 10 breeding sheep must be entered by the date set for show entries to have a breeding show. All breeding sheep will show together and be divided into classes by age. Age will be determined by the show veterinarian upon check in.
- 4. Breeding Sheep Classes -
 - 1. Ewe Lambs
 - 2. Two Tooth Ewes
 - 3. Aged Ewes

- 4. Champion Female
- 5. Res. Champion Female
- 5. Market Lambs: will be judged after the Breeding Sheep
- 6. Market Sheep will be divided into classes as determined by the Superintendent following the weighing. Breeds of Market Lambs are: Finewool, Finewool Crosses, Medium Wool (8 classes), and Southdown and Hair-Sheep.
- 7. Market lambs must be slick shorn and of uniform length from knee and hock up prior to arrival. Only touch ups can be made on the show grounds with any type of clippers. Any lamb that shows up in full fleece will be disqualified from the show.
- 8. Market lambs will show in the breed where it appears to exhibit predominant breed characteristics, as determined by the classifying committee- Two head will make a breed.
- 9. Ewe lambs shown in the Market Class will not be permitted to show in the Breeding Sheep Show.
- 10. Market sheep will be weighed in and classified in the cattle wash rack area immediately following admittance from the show vet, post fungus check. Sheep being shown in the medium wool class do not need to be classified.
- 11. The minimum weight limits for lambs are as follows: Hair Sheep and Southdowns: 80 Pounds, and all other breeds including medium wool, fine wool, and crosses will have a minimum weight of 90 pounds.
 - OFFICIAL WEIGH IN will be immediately following fungus check.
- 12. Lambs/goats are not allowed to enter the lamb/goat barn until they have been cleared by the show veterinarian.
- 13. Inspection for live ringworm/fungus by the show veterinarian will take place from 7-10 AM on the Wednesday of the show week inside the cattle wash racks. Chapters and clubs should arrive based upon the time schedule created by the sheep superintendent or their designee. Each animal (market and breeding) will be examined by the show veterinarian(s) to gain access in the barn. All blankets and muzzles must be removed from animals and must be shorn according to the show regulations prior to inspection. The sheep/goat superintendent, show veterinarian(s), exhibitor, and chapter advisor or club representative are the only individuals permitted inside the cattle wash racks at the time of inspection. Animals with live ringworm and/or fungus (as deemed by (both) the show veterinarian(s) of the county show) will not be permitted to enter the lamb/goat barn and will not be permitted to participate in the Youth Show." The decision of the Show Veterinarian's is final.
- 14. Sale order will be determined by the judge at the completion of each breed. The overall Champion and Reserve Champion will be the first two market lambs in the sale. After Champion and Reserve Champion are selected, the remaining breed and reserve breed champion lambs will be selected in order by the judge for sale order, with the remaining sheep being selected to make the 33% sale order.

- 15. Showmanship will follow the conclusion of the sheep show.
- 16. At the conclusion of the fungus check/official weigh in each School/Club will be presented with "One" print out of their entries. All Changes will be made on this form and turned in to the show office within 30 minutes. Teachers/Leaders shall verify the information and sign.
- 17. All coverings are to be removed prior to fungus check.
- 18. All tags are to be removed with the exception being what pertains to validation and breeding. All lambs and goats have only validation tags at the time of check-in.

Rabbit Division

Superintendent: Samantha Podlucky Assistant: Olivia Dodson

- 1. Entries are subject to general rules. This is a carrier show
- 2. Ownership / Possession: meat pens must be owned and in the possession of the exhibitor four (4) weeks prior to show date. Breeding must be owned and in the possession of the exhibitor six (6) weeks prior to show date.
- 3. Meat pens will consist of 3 rabbits—all the same breed and variety. AGE LIMIT not over 10 weeks of age. Minimum weight per rabbit is 3 pounds 8 ounces and the maximum weight is 5 pounds 8 ounces. If you have one or more rabbits less than 3 pounds 8 ounces or one or more over 5 pounds and 8 ounces it will result in being disqualified and your pen will need to be returned to your carrier. It will not go to the show table.
- 4. Top 8 pens or 33%, whichever is greater, of meat pens that qualify for the show are eligible for the Ribbon Auction, excluding the Grand and Reserve Champion Pens. Percentage will be rounded to the nearest whole number. Heavy and lightweight rabbits will be allowed to bump up when ¼ or 33% of the class is not being sold due to an exhibitor pulling a heavy or lightweight rabbit out of the sale.
- 5. Rabbits are to be a recognized breed from the current Standard of Perfection published by ARBA.
- 6. Meat pen rabbits must be tattooed by a committee member or volunteer secured by the superintendent at the specified date and time of validation with a CCJLS specific tattoo.
- 7. Breeding rabbits without permanent tattoos will not be allowed to show. Breeding rabbit exhibitors may bring their rabbits to validation to be tattooed, if needed at a cost of \$5 per rabbit.
- 8. Mating of rabbits is prohibited on the show grounds. Anyone in violation of this rule will be removed from the show and forfeit all awards.
- 9. Breeding entries can be changed the morning of the show as long as they are the same class, same sex, and same breed but must be designated before the start of the breeding show. Late entries are accepted as well but must be turned in and paid for before the breeding show begins. Any changes that need to be made must be made before the breeding show begins also. Breeding rabbit exhibitors are required to check in and verify their rabbit information. Changes to the class, breed or sex will result in a \$5 fee. Instructions to check in and make changes will be given over the loudspeaker. If an error is found while the committee members are lining up classes on the show table, you will not be allowed to show. Take care of any changes before the show begins.
- 10. All Best of Breed Rabbits will compete for Best in Show and Reserve in Show.
- 11. Meat Pen rabbits will be broken down into two weight divisions. Lightweight and Heavyweight. They will be broken down by the pen of 3 total. Lightweight will be 10 pounds 8 ounces 13 pounds 8 ounces. Heavyweight will be 13 pounds 9 ounces 16 pounds 8 ounces. The top two from each weight division will compete for Grand and Reserve of Show. The percent of sale will come out of both weight divisions.
- 12. The Judge will be an official ARBA licensed judge, when possible and ARBA rules will be followed for the judging of the breeding show.
- 13. Exhibitors **MUST** place their rabbits in the cages to be presented for judging.

Each exhibitor is required to bring feed and water containers, and feed and water for each pen entered along with bedding.

Breeding Poultry arrives in the stall barn.

Broiler Division:

- 1. A broiler pen will consist of a uniform group of three birds from the original order. Pen may include birds of either sex.
- The top (8) pens or 33%., whichever is greater, of Broilers will be sold at the sale as determined by the number of entries, excluding the Grand and Reserve Champion. Poultry will be allowed to bump up when ¹/₃ or 33% of the class is not being sold due to an exhibitor pulling another poultry entry out of the sale.
- 3. The exhibitor must be with his/her birds while judging is performed. (Exceptions must be approved by the Superintendent).
- 4. A validation change of ownership form may be submitted 24 hours prior to pick up of broilers to change eligible exhibitor(s).
- 5. Wing bands will be checked and must reflect number series as assigned by the superintendent at pick up. Pens that include birds with band numbers not in assigned series will be disqualified.
- 6. Non-banded birds will be disqualified

Breeding Division:

- 1. Exhibitors may enter as many as 5 birds per division
- a. Standard Cock (More than 12 months)
- b. Standard Hen (More than 12 months)
- c. Standard Cockerel (Less than 12 months)
- d. Standard Pullet (Less than 12 months)

- e. Bantam Cock (More than 12 months
- f. Bantam Hen (More than 12 months)
- g. Bantam Cockerel (Less than 12 months)
- h. Bantam Pullet (Less than 12 months)

- 2. Exhibitors must be present at Judging.
- 3. Exhibitors must check in all entries with the superintendent prior to being penned
- 4. Exhibitors must provide a copy of the current Pullorum-Typhoid test at check-in to be retained by the superintendent
- 5. Judging will be conducted according to standard of perfection for each variety represented in each division
- 6. An entry may only be subbed for the same breed and same sex.

Highlights from the General Rules:

- Only one pen of broilers may be sold per exhibitor.
